The California Air Resources Board (CARB) is implementing a comprehensive heavy-duty vehicle inspection and maintenance regulation: the Clean Truck Check (CTC) program. Under this rule, any heavy-duty diesel and alternative fuel vehicles (2013 and newer) with a gross vehicle weight rating of more than 14,000 pounds must have a properly functioning emissions control system when traveling on California's roadways. And yes, that includes vehicles registered outside of California.

Ninety-day (90-day) submission windows dictate compliance deadlines based on the vehicle's registration. The scan deadline is six months after the expiration date of California registration. For vehicles not registered in California, eligibility is determined by the last digit of the VIN.

Enforcement is scheduled to begin on January 01, 2025.
