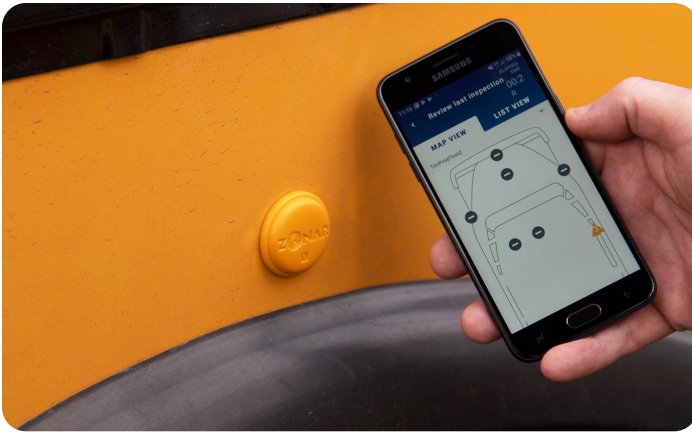

How it works.

Zonar EVIR is a patented, one-of-a-kind visual inspection system that ensures every required inspection is conducted properly, every time.

- Place a Zonar tag on each inspection zone of the vehicle or piece of equipment.
- Drivers and operators must physically scan each tag when they inspect that zone's components.
- As they perform the inspection, they mark defects, add notes and capture photos.
- When the inspection is complete, the results are uploaded into our fleet management platform through the Zonar V4™ telematics unit.
- Inspections are done from either a Zonar-enabled tablet or their iOS or Android device.

EVIR complies with all DOT, OSHA, MSHA and PTASP regulations. And, unlike DVIR and eDVIR solutions, EVIR inspections are truly verifiable.

The RTA fleet maintenance software seamlessly receives EVIR real-time data, showing any defects and repairs identified during the operator's inspection.

Inspection repair data is available immediately in the Driver Reports module. Work orders are easily generated directly from the report, reducing time needed for data entry and freeing up shop time for other essential tasks.

When the work orders are complete, the vehicle's primary driver receives an automated back-in-service alert. Plus, daily odometer and meter readings from the vehicle are updated into its master file, allowing for punctual alerts as well as scheduling of preventive maintenance and routine shop inspections.
